

Corporate Individual Scheme (CIS) Terms & Conditions

Zero1 CIS is an exclusive programme offered to staff of participating companies. With this scheme, the employees get to enjoy savings on their monthly subscription when they register for Zero1 services as an individual.

- CIS is applicable to organisation with minimum staff strength of 10 in Singapore.
- Only registered organisations are eligible for the CIS.
- Application is subject to Zero1's approval and at its sole discretion.
- Upon approval, the business email (eg. xxx@Zero1.sg) will be whitelisted to effect the promotion.
- Organisation who wishes to register for its subsidiary company should submit separate application.
- Promotion Code will be assigned to the organisation. The 10% promotion discount applies to monthly subscription for all mobile plans except the 1GB To Unlimited plan, promotional plans and add-ons.
- Employees will be required to use the Promotion Code and their respective business email address to subscribe to Zero1 services online. In additional, they will be required to submit their employment details and upload their staff pass. The Promotion Code is found at the Order Summary Page and the promotion rate will be applied at Check Out.
- Promotion Code is available during the CIS validity period unless otherwise notified by Zero1.
- Promotion is valid for employees of the organisation with a valid employment identity. Zero1 reserves the right to reject and/or terminate the subscription without notice if the identity is not valid.
- Promotion is valid for new subscribers only. Each individual subscriber can register up to a maximum of 6 lines under the same account.
